1.

The Oregon Medical Board (Board) is the state agency responsible for licensing, regulating and disciplining certain health care providers, including physicians, in the State of Oregon. Rajninder Kaur Jutla, MD (Licensee) is a licensed physician in the State of Oregon.

2.

On January 11, 2023, the Board issued an Amended Notice of Proposed Disciplinary Action in which the Board proposed to take disciplinary action against Licensee pursuant to ORS 677.205(2), including revocation of license, a \$10,000 civil penalty, and the costs of the proceeding, not to exceed \$100,000. The Board proposed to take this disciplinary action for violations of the Medical Practice Act, specifically: ORS 677.190(1)(a) unprofessional or dishonorable conduct, as defined in ORS 677.188(4)(a) any conduct or practice which does or might constitute a danger to the health or safety of a patient or the public and ORS 677.188(4)(c) employment of outmoded treatment; ORS 677.190(13) repeated acts of negligence; ORS 677.190(15) disciplinary action by another state of a license to practice, based upon acts by the licensee similar to acts described in ORS 677.190; and ORS 677.205(2)(d) failing to make a report required under ORS 677.415.

Licensee and the Board desire to settle this matter by the entry of this Stipulated Order. Licensee understands that she has the right to a contested case hearing under the Administrative Procedures Act (Oregon Revised Statutes chapter 183), fully and finally waives the right to a

1 contested case hearing, understands and acknowledges that this order is not subject to judicial  
2 review, and acknowledges and agrees the grounds to petition for the stipulated order to be set  
3 aside under ORS 183.417(3)(b) do not exist in this case, by the signing of and entry of this Order  
4 in the Board's records. Licensee does not admit, but the Board finds that Licensee engaged in  
5 conduct as described in the January 11, 2023, Amended Notice of Proposed Disciplinary Action,  
6 and that this conduct violated the Medical Practice Act, to wit ORS 677.190(1)(a) as defined in  
7 ORS 677.188(4)(a) and ORS 677.188(4)(c); ORS 677.190(13); ORS 677.190(15); and ORS  
8 677.205(2)(d). Licensee understands that this Order is a public record and is a disciplinary  
9 action that is reportable to the National Practitioner Data Bank and the Federation of State  
10 Medical Boards. Licensee understands the terms of this Order and signs freely.

12 Licensee and the Board agree that the Board will close this investigation and resolve this  
13 matter by entry of this Stipulated Order, subject to the following conditions:

14 4.1 Licensee surrenders her Oregon medical license while under investigation.

15 4.2 Licensee agrees to not reapply for a license to practice medicine in Oregon for at  
16 least four years from the effective date of this Order.

17 4.3 Licensee is assessed \$10,000 in costs related to the preparation of the contested  
18 case hearing which was set to begin on July 10, 2023.

19 4.4 The Board agrees to close all investigations related to the matters underlying the  
20 Washington Medical Commission's orders that are the basis for reciprocal discipline herein.

21 4.5 Licensee agrees to not bring any civil actions against the Board for any alleged  
22 acts or omission that have occurred up to and through the date this Order is signed by the Board  
23 Chair.

24 4.6 Licensee must obey all federal and Oregon state laws and regulations pertaining  
25 to the practice of medicine.

26 4.7 Licensee stipulates and agrees that any violation of the terms of this Order shall  
27 be grounds for further disciplinary action under ORS 677.190(17).

This Order becomes effective the date it is signed by the Board Chair.
