

1 has subsequently learned that Licensee was indicted in Deschutes County, Oregon, on April 10,
2 2007, on 18 counts of Sexual Abuse III, in violation of ORS 163.415, for allegedly subjecting 11
3 adult female patients to unlawful sexual contact. Dr. Lee has entered a plea of not guilty and his
4 trial is pending as of this date.

6 Licensee and the Board now agree that the Board will close this investigation and
7 Licensee will cease from practicing as a physician in the State of Oregon by surrendering his
8 license under investigation, consistent with the terms of this Order. Consistent with Licensee's
9 plea of not guilty in the criminal case, Licensee disputes the charges and makes no admission of
10 misconduct. However, the Board finds that Licensee engaged in the conduct alleged in
11 paragraph 3 and that this conduct violated ORS 677.190(1)(a) unprofessional or dishonorable
12 conduct, as defined in ORS 677.188(4)(a), (b) and (c) and ORS 677.190(14), gross or repeated
13 acts of negligence. The parties acknowledge that the terms of this Order will not be affected by
14 any later findings, judgments, or other resolution entered in regard to the pending criminal case.
15 Licensee understands that he has the right to a contested case hearing under the Administrative
16 Procedures Act (chapter 183), Oregon Revised Statutes and fully and finally waives the right to a
17 contested case hearing and any appeal therefrom by the signing and entry of this Order in the
18 Board's records. Licensee understands that this document is a public record and is reportable to
19 the National Practitioner Data Bank.

21 Licensee and the Board agree to resolve this matter by the entry of this Stipulated Order
22 subject to the following conditions:

23 5.1 Licensee surrenders his license to practice medicine while under investigation.

24 This surrender becomes effective the date the Board Chair signs this Order.

25 5.2 Licensee is reprimanded.

26 5.3 Licensee stipulates and agrees that he will never apply for a license to practice

5.4 By the terms of this agreement, Licensee will not practice any form of medicine, including but not limited to, individual medical examinations (IME's).
